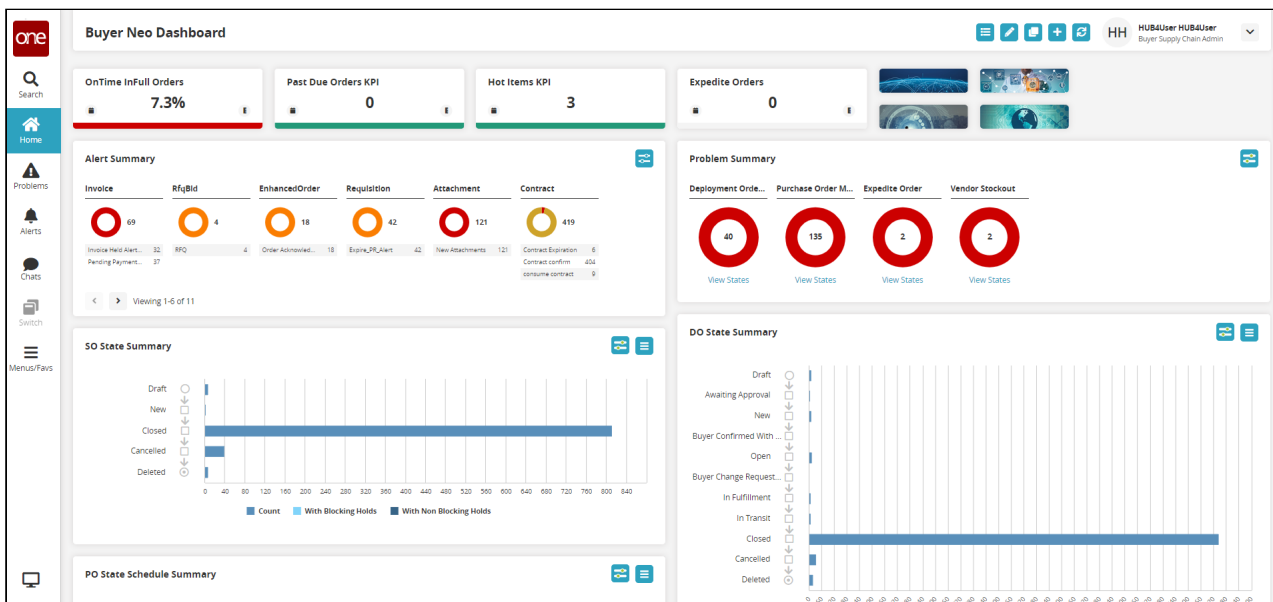

The NEO user interface (UI) modernizes the user experience and makes navigation more natural and intuitive. NEO UI includes the same great features and functions as Command Center UI, with added convenient features. NEO UI allows for more effective data visualization via a redesigned user dashboard and new Widgets (previously portlets). NEO UI enables users to work more quickly, finding the data they need when they need it. Commonly used items, including alerts, favorites, menus, and search, have moved from the top of the screen to the left side navigation panel. The relocation of tabs, now called Perspectives, to the switch menu, provides users with more viewing area for data visualization.

NEO UI includes significant changes to the User Dashboard. The Dashboard is now more configurable and can present more data than before in one, easy-to-read screen. Additionally, users have the option to create multiple dashboards for visualizing different types of data and further reducing on-screen clutter.

Users have the option to use either the legacy Command Center UI or NEO UI by selecting a preferred UI from their user profile settings.

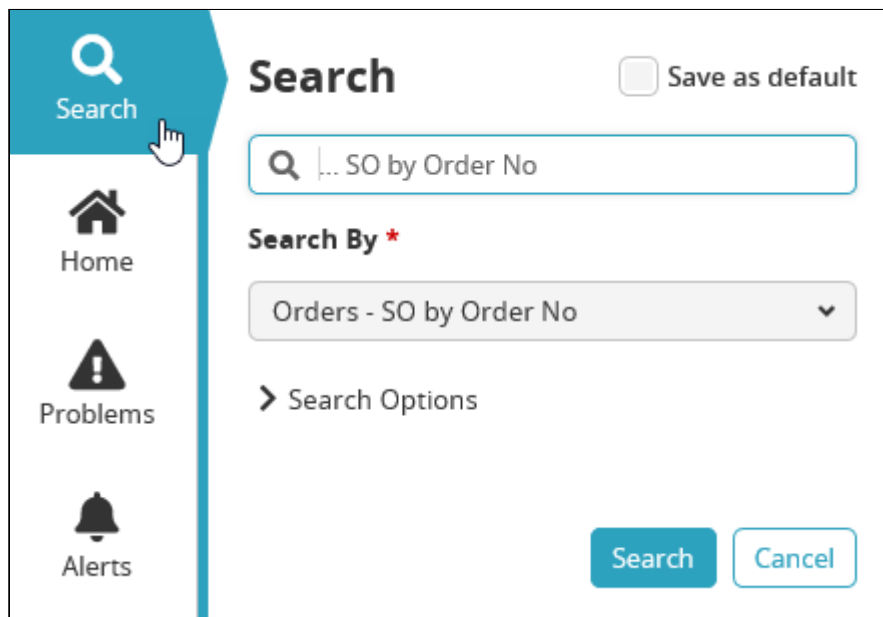


2 Global Search

The NEO global search allows users to search for orders, shipments, appointments, contracts, claims, requisitions, and other items depending on the user role.

Complete the following steps to use the NEO global search:

1. Click on **Search** in the left sidebar.
The **Search** slide-out displays.



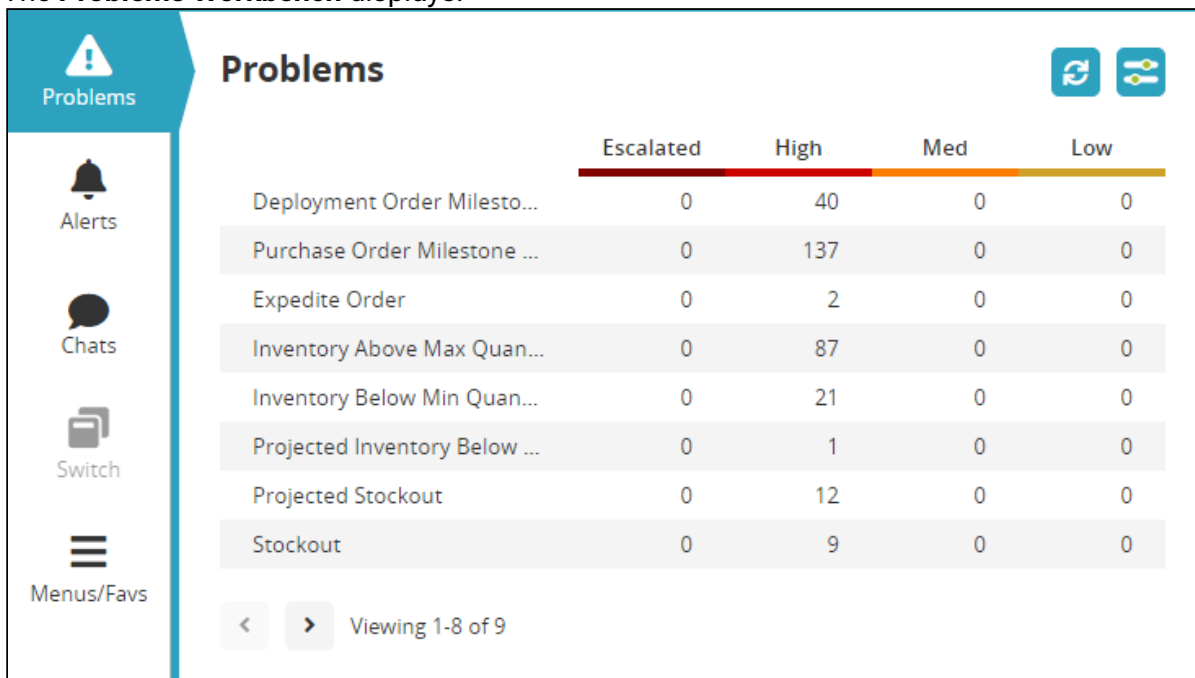
2. Select a search item from the **Search By** drop-down menu.
The top search field populates with the search criteria.
3. Type in search criteria in the **Search** field.
4. Click the down arrow next to **Search Options**.
5. Select the time period from the **Retrieve For** drop-down menu.
6. Click on **Search**.
The report for the search criteria specified displays.

3 Using the Problems Workbench

The new **Problems Workbench** slide-out in the NEO UI replaces the Problems portlet from the Command Center UI. The workbench slide-out is located on the left navigation sidebar so that users have quick and immediate access to problems from the NEO UI.


Complete the following steps to use the Problems Workbench:

1. Select **Problems** in the left sidebar of the NEO UI.
The **Problems Workbench** displays.

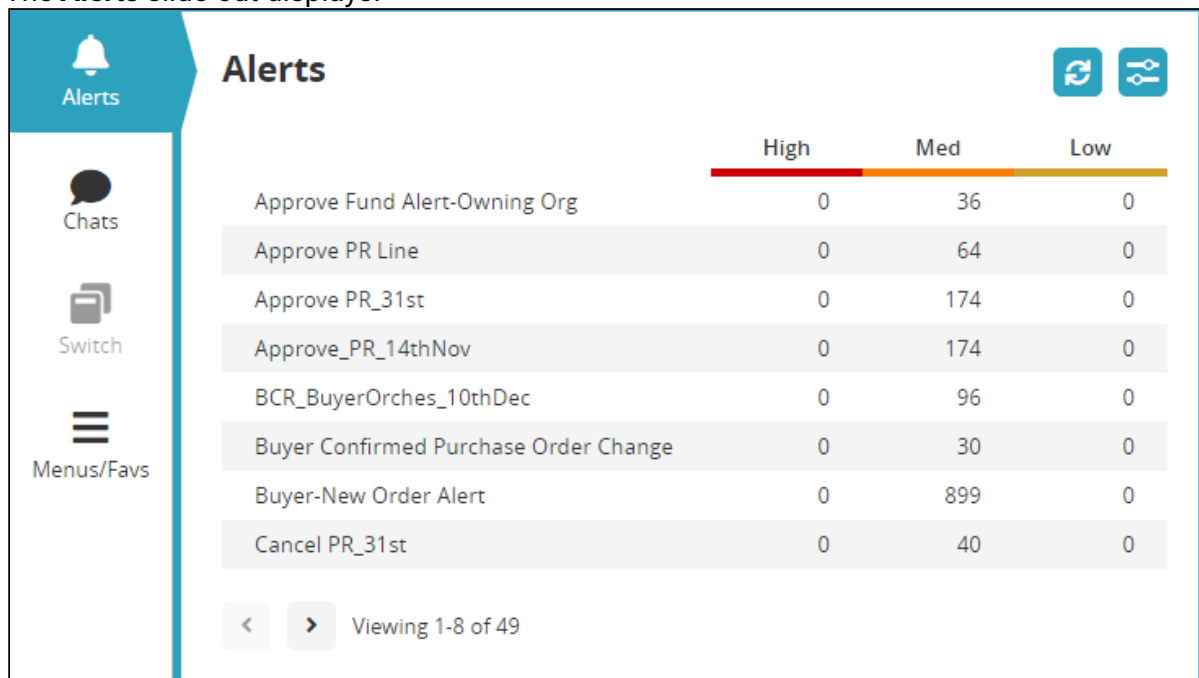

4 Alerts

The new Alerts slide-out in NEO UI is the Alerts portlet from the Command Center UI. The slide-out is located on the left navigation sidebar so that users have quick and immediate access to alerts from the NEO UI view.

1. Click on **Alerts** in the left sidebar of NEO UI. The **Alerts** slide-out displays.

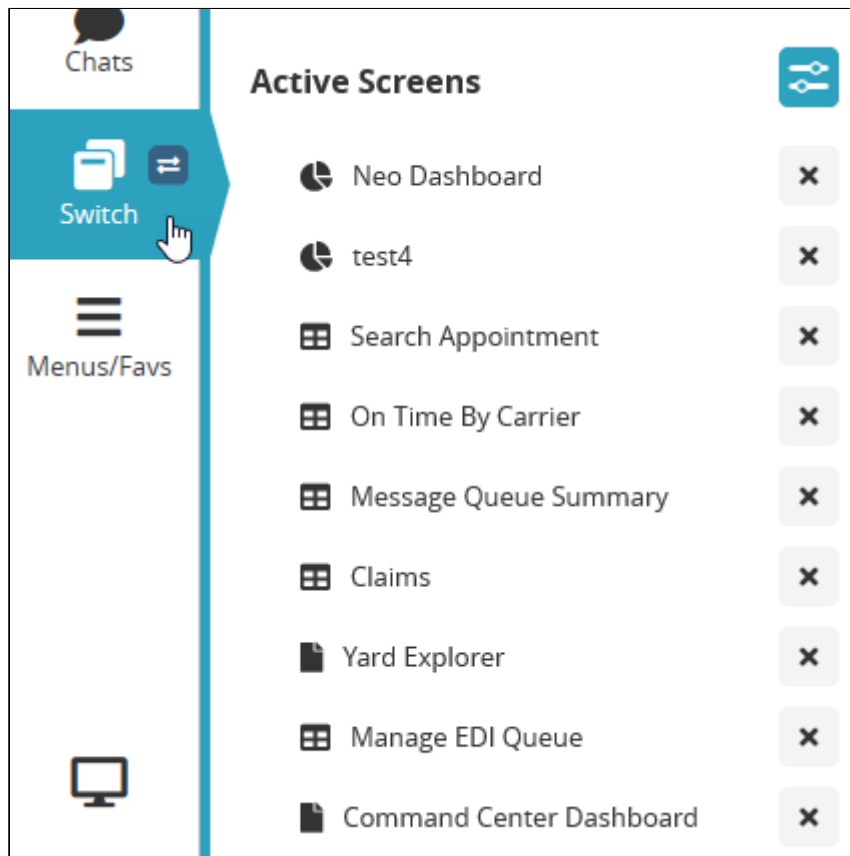

5 Screen Switching

Complete the following steps to switch between screens (or perspectives):

1. Click on **Switch** in the left sidebar of NEO UI.
A slide-out menu of **Active Screens** (perspectives) displays. The list of screens is based on the current login session; screens do not save from session to session. If the user has just logged in, the **Switch** menu is cleared, and the icon is grayed out and inactive.



2. Click on the screen name (perspective) from the list.
The screen (perspective) displays.

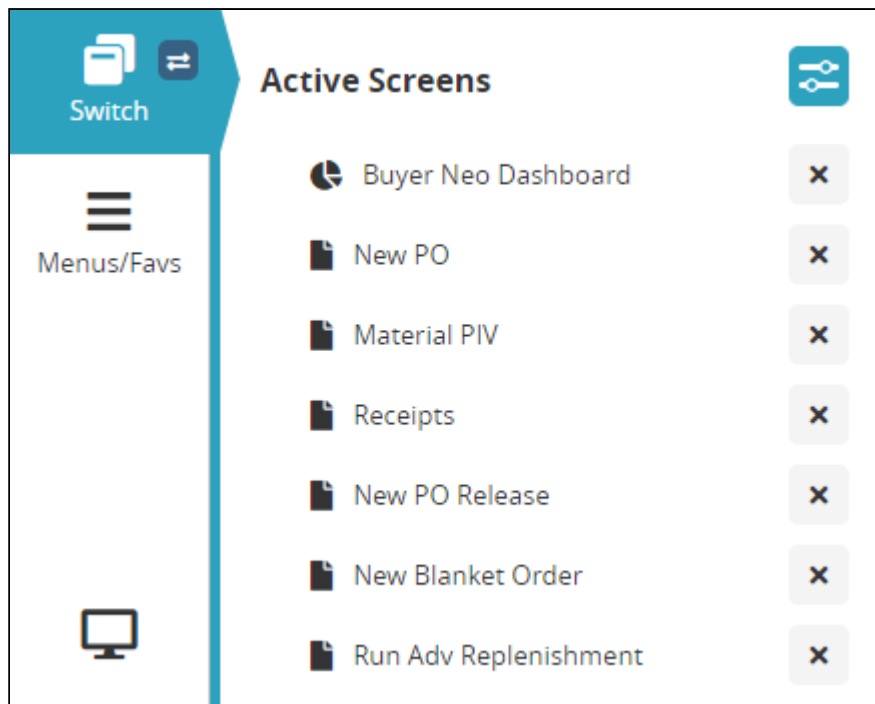
The number of active screens displayed on the Switch menu is limited to 12. User preferences can be adjusted in User Settings.

5.1 Configuring the Screen Switcher

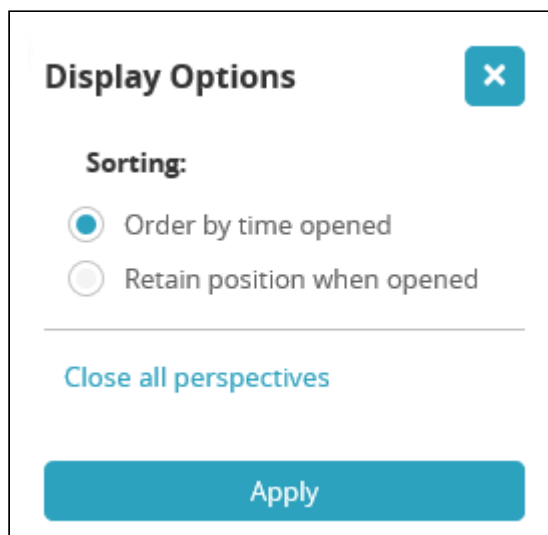
Complete the following steps to configure the Screen Switcher:

1. Click on **Switch** on the left sidebar of NEO.
The UI displays the slide-out menu of **Active Screens** (perspectives). The list of screens is based on the current login session; screens do not save from session to session. If the user

has just logged in, then the **Switch** menu is cleared, and the icon is grayed out and inactive.



2. Click on the **Filter Options** button.
The UI displays the **Switcher Display Options** dialog box.



Options for displays of the screens include

- Order by time opened** - the longest opened screen/perspective remains on the top of the list
- Retain position when opened** - the order is based on what screen/perspective the user

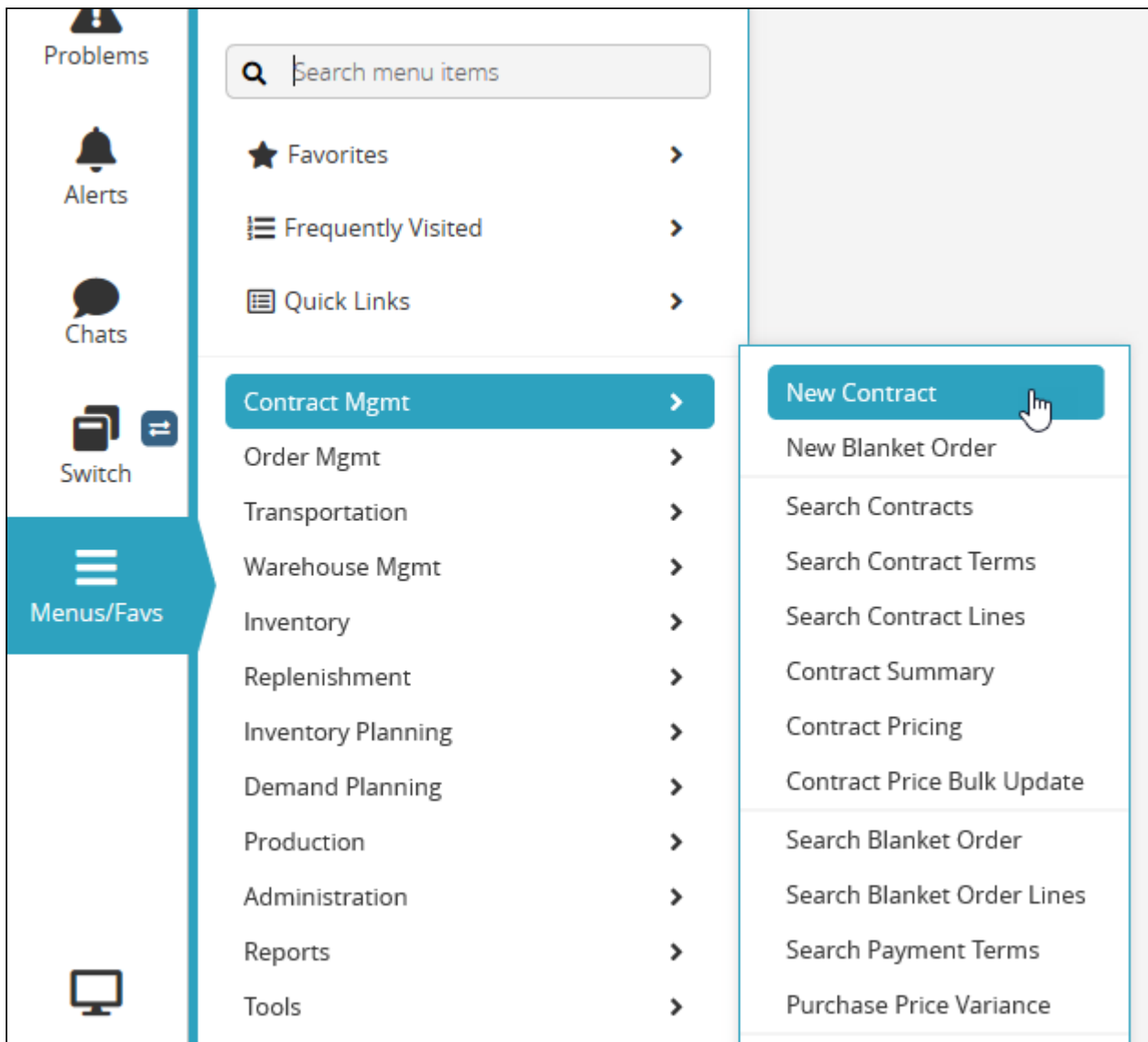

3. Click the radio button in front of the option to select it.
4. Click on **Apply**.
5. Click on **Close all perspectives** to close all screens/perspectives.

The number of active screens displayed on the Switch menu is limited to 12. User preferences can be adjusted in User Settings.

6 Working with Menus

The menus from the Command Center UI have moved to the left sidebar within the NEO UI. Select **Menu/Favs** to display the menus. Submenus will slide out to the right.

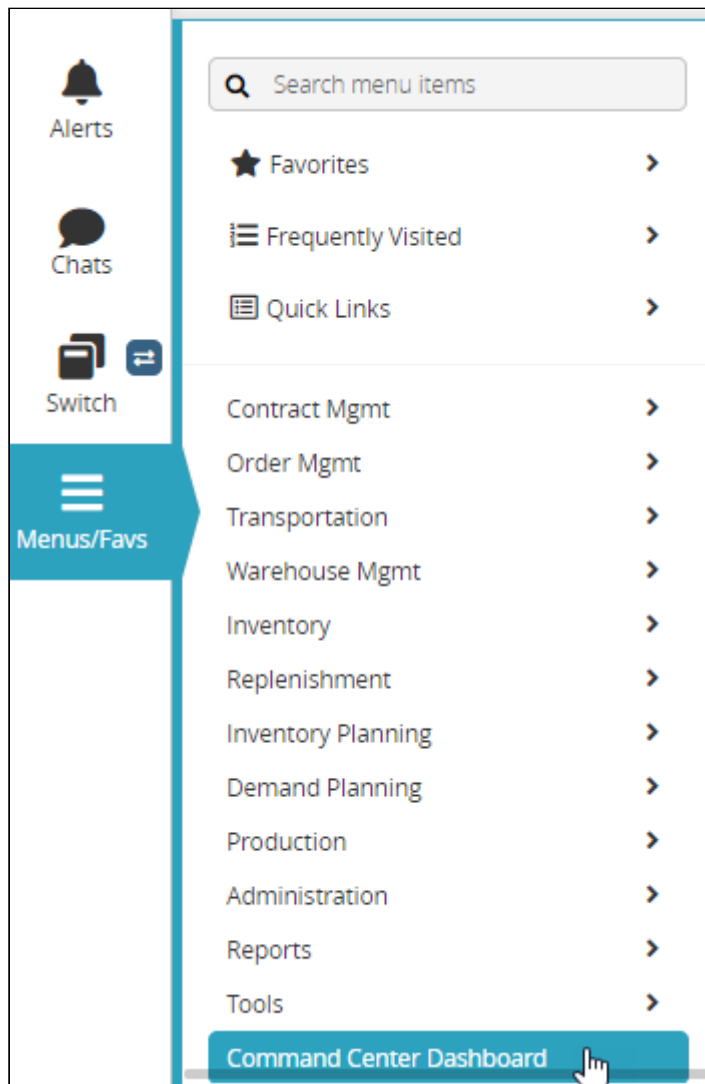


6.1 Command Center Dashboard in NEO UI

1. Select **Menu/Favs** from the left sidebar in the NEO UI.



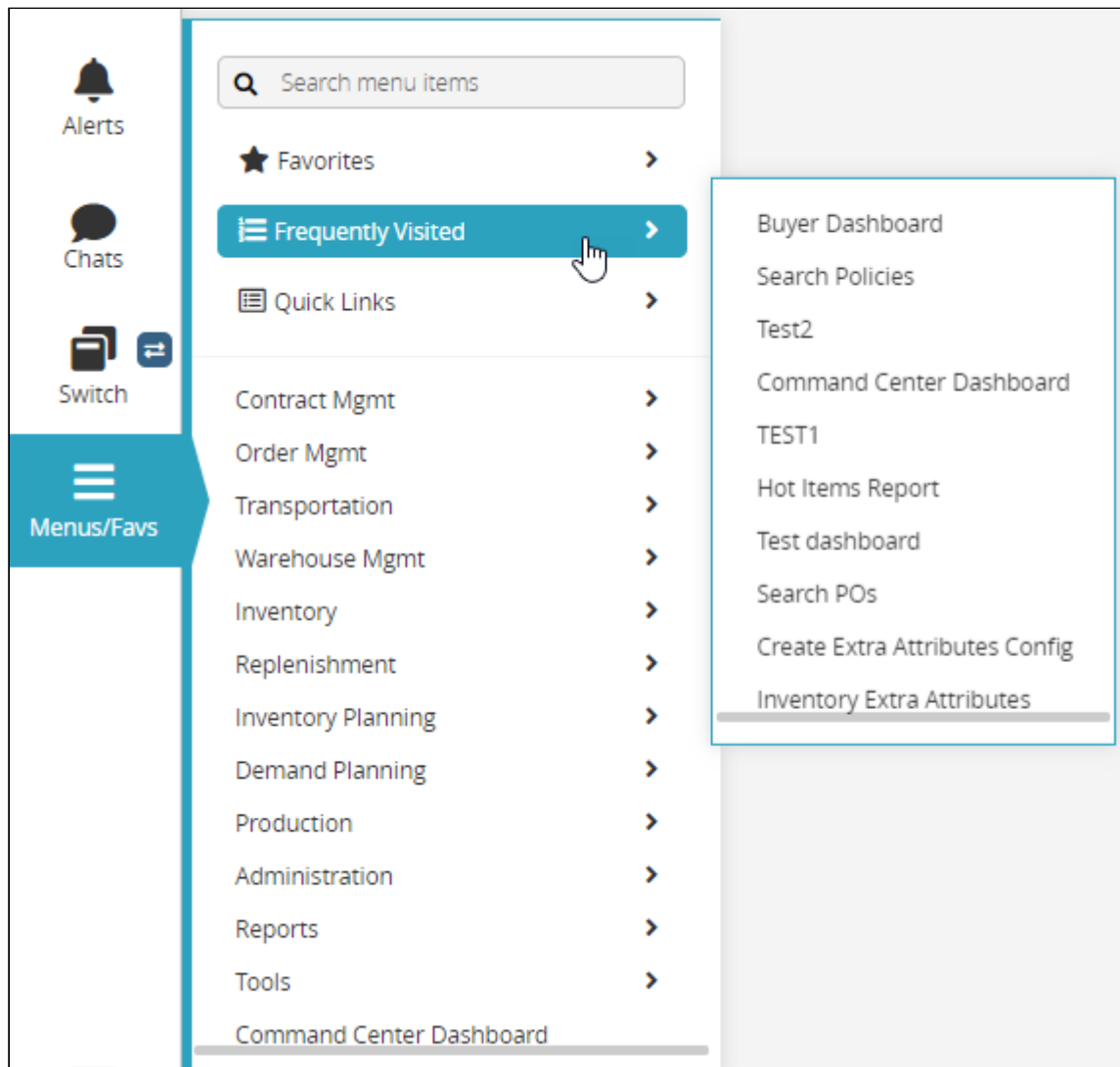
2. Select **Command Center Dashboard**.

6.2 Frequently Visited

Frequently visited pages and dashboards are compiled in the NEO UI in the **Frequently Visited** menu.

Complete the following steps to find a frequently visited page or dashboard:

1. Select **Menu/Favs > Frequently Visited** in the left sidebar of the NEO UI. A list of frequently visited pages or dashboards displays.



3. Click on the link for the page.

6.3 Quick Links

The NEO UI offers the same quick links as the Command Center UI under the **Menu/Favs** sidebar menu.

6.3.1 Using Blipper

Blipper can now be found in the NEO UI from Quick Links.

Complete the following steps to use Blipper from Quick Links:

1. Select **Menu/Favs > Quick Links > Blipper**.
The **Blipper** window opens.

2. Type in your message in the comment box.
3. Select the distribution list.
4. Click **Blip It**.

6.3.2 Accessing Documentation

Complete the following steps to access NEO documentation and Online Help:

1. Select **Menu/Favs > Quick Links > Documentation**.
The **Online Help** displays.
2. Use the search embedded in the help to locate the desired content.

6.3.3 Viewing Keyboard Shortcuts

NEO UI comes with keyboard shortcuts to help users work more efficiently.

Complete the following steps to display commonly used keyboard shortcuts:

1. Select **Menu/Favs > Quick Links > Keyboard Shortcuts**.
The **Keyboard Shortcuts Help** dialog box displays.
2. Click the X or press escape to close the window.

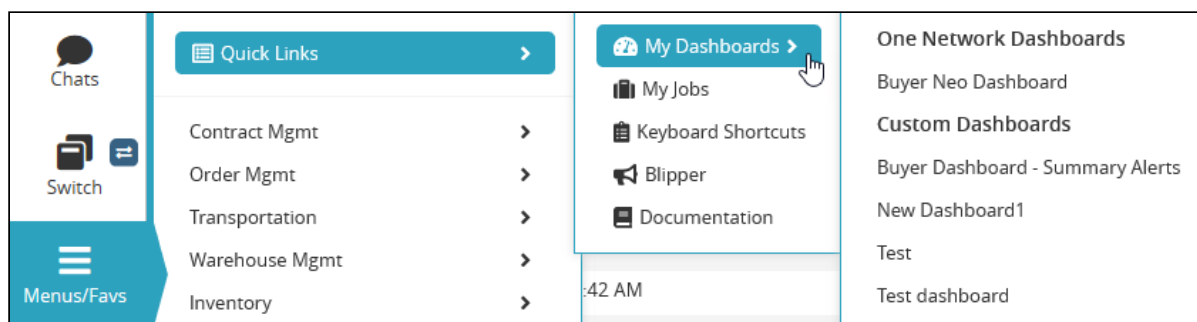

The dashboard displays.

6.3.5 Viewing My Jobs

Users can configure specific transactions to run in the background if they pass certain thresholds. For example, a shipment tender can be set up to run as a background process if 10 or more shipments are selected, and this will display on the My Jobs page.

Complete the following steps to get to the listing of My Jobs from Quick Links:

1. Select **Menu/Favs > Quick Links > My Jobs**.
The **My Jobs** screen displays all jobs running as background processes.

4. Click on **Batch jobs** to see Batch jobs.

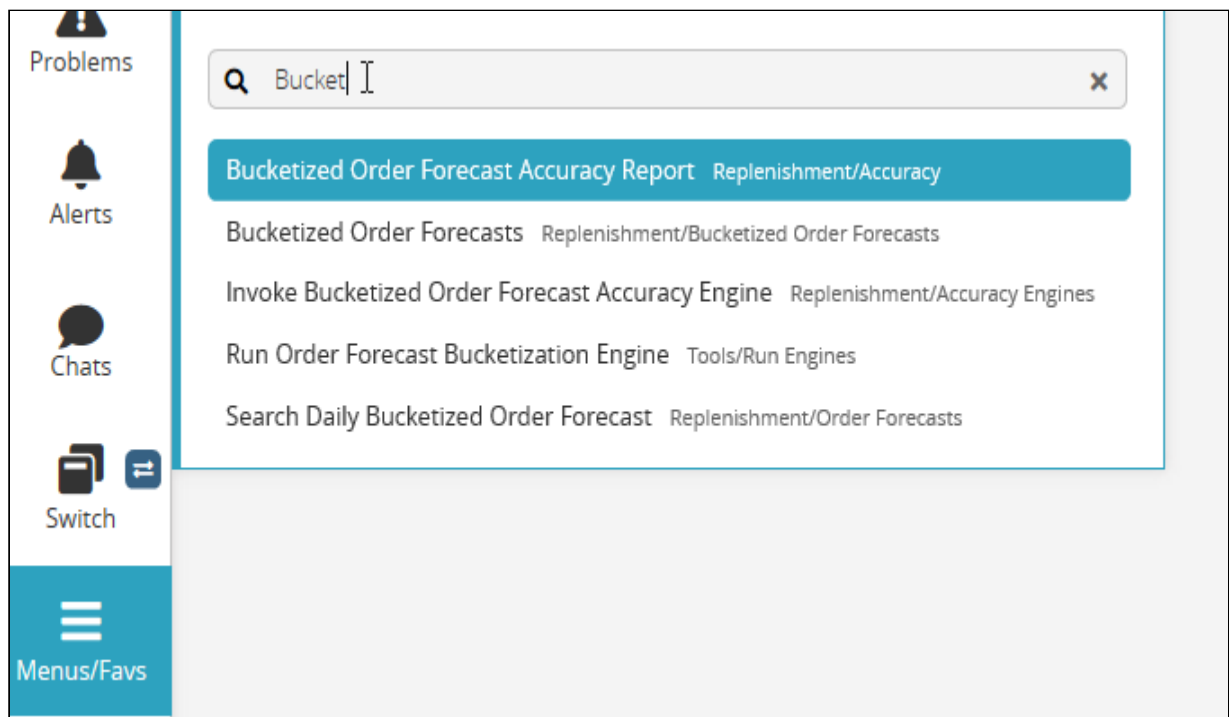
6.4 Using the Menu Search Bar

Users who are familiar with menus in their daily work may find it is easier to use the menu search bar to get to a specific menu.

Complete the following steps to use the menu search bar:

1. Select **Menu/Favs** in the left sidebar of the NEO UI.
2. Click into the **Search Bar** at the top of the slide-out menu.
3. In the Search Bar, type in a menu item name.

The UI displays a list of menu items matching your entry in the search bar. The Search is reactive, so partial matches will yield results.



4. Select the menu item from the list.

7 Favorites

Favorites are ONE Network's answer to bookmarking screens and searches. The NEO UI offers rich support for working with favorites.

7.1 Adding Favorites

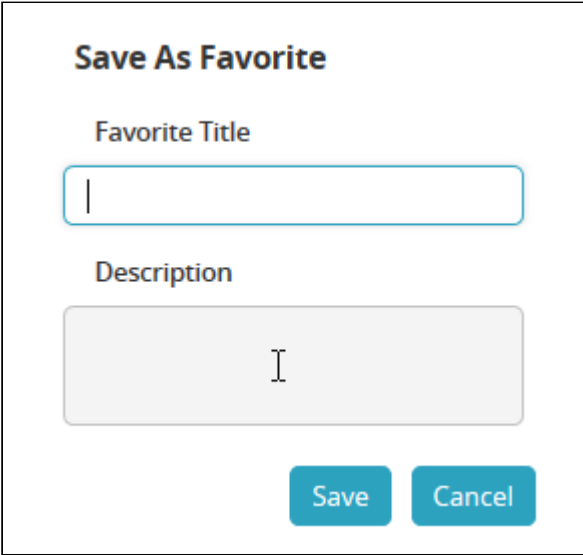
Add a favorite (or bookmark) for a screen or a search that you would like to return to.

Complete the following steps to add a screen or search as a favorite:

1. Navigate to a screen or perform a search.

2. Click on the **Save As Favorite** button. 

The **Save As Favorite** dialog box appears.



3. Enter a title in the **Favorite Title** field.
4. Enter a description of the page in the **Description** field.
5. Click on **Save**.

A dialog box displays to notify the user that the favorite was saved.
6. Click on **OK**.

7.2 Deleting Favorites

Complete the following steps to delete a screen or search from favorites:

1. Select **Menu/Favs > Favorites > Manage Favorites**.

The **Manage Favorites** screen displays with a list of all of your **Favorites**.

The **Manage Favorites** screen displays with a list of all **My Favorites**.

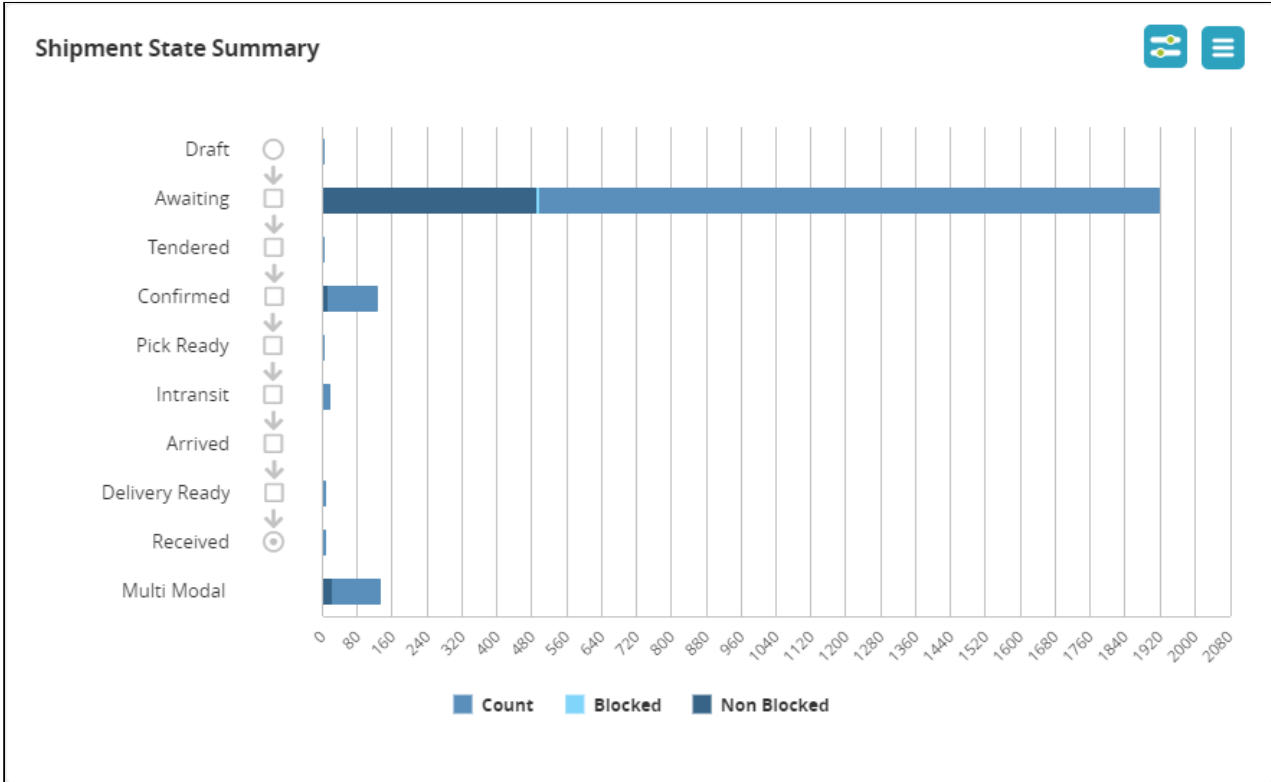

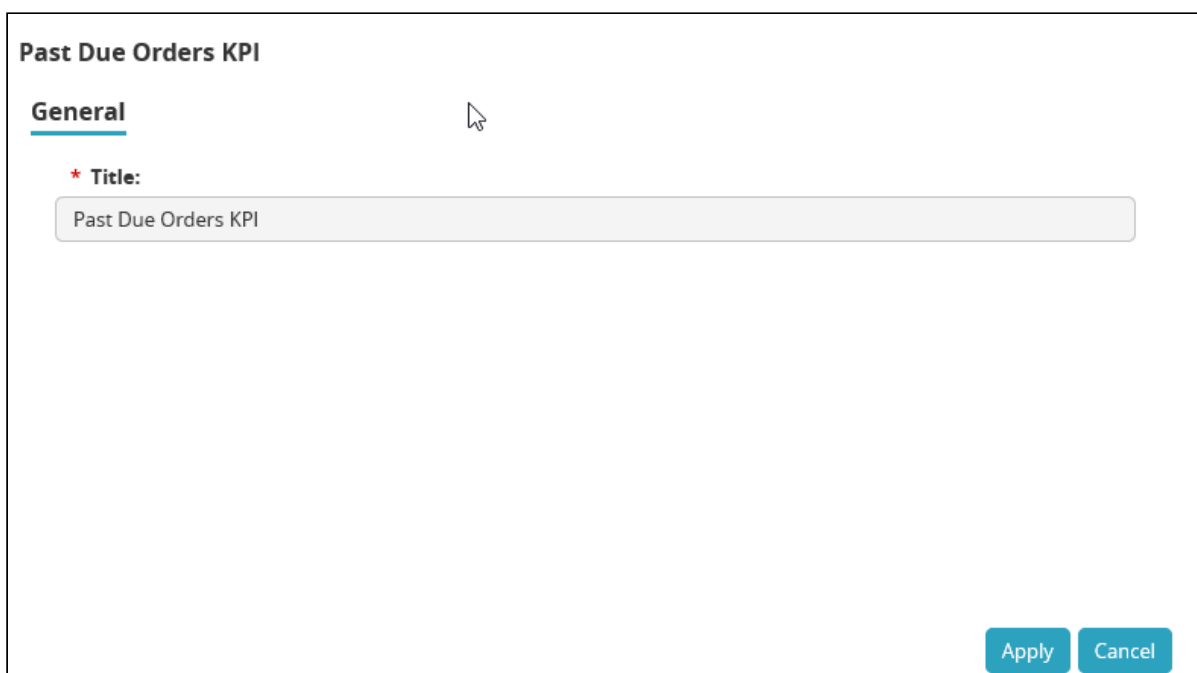
